MANDI (H.P), There were various sites explored for establishing of Hospital as per Joint Inspection but the Site at Sandhol has been finalized as it involved overall minimum forest length and minimum number of trees in comparison to other sites. There is no availability on non forest land in the Near by area for proposed project & in another sites more area involved & large no of trees were coming and great loss to environment. Hence there is no escape of forest land. The Hospital is mandatory in the to facilitate easy and early approach all kinds of patients particularly the old age/ senior citizens and children for their treatment. The DPR of Hospital has already been prepared but the same was received with observations that prior approval under FCA-1980 was required to be obtained from forest Deptt. before sanction of this DPR. Accordingly forest land diversion case has been prepared. All possible measure has been taken to involve minimum possible forest area. All alternatives were explored and this one taken as final for preparation of DPR & Forest Case.
