Sir,

The proposal as received vide your letter cited under reference above, for issue of revised sanction on the basis of lowest evaluated tender cost along with checklist & other details for the above work have been examined and I am directed to convey Re-revised sanction amounting to **Rs. 89.41 lacs (Rupees Eighty Nine lacs and Forty One thousand only)** against the original A/A & E/S for Rs. 88.46 lacs dated 09.10.2018 along-with following remarks:

1. The component wise various revised provisions accorded shall be as per the details given in **Annexure-A**. No deviation from approved provisions shall be made without approval of NVS-HQ.
2. The CA is requested to re-check the entire process again for its correctness before acceptance of tender. The correctness of tender process, reasonability & justification of cost recommended for issue of revised sanction rests with Construction Agency (CA). It is also presumed that the tenders have been invited in the most open and transparent manner and the cost recommended for issue of revised sanction is competitive. Market Rate Justification, Analysis of rates and other documents related to tenders shall be kept in record by CA for any future reference & requirement by NVS. CA shall make available such records on demand if required so at a later date in future.
3. The tenders shall be accepted by the Competent Authority of Construction Agency after ascertaining the correctness and reasonability of the tenders and its complete process.
4. The revised approval of the RPE is being issued considering that the entire process has been done in accordance with CPWD rules/guidelines, GFR-2017 and latest GoI guidelines issued in this regard. Any omission, error if so found shall be immediately brought to the notice of NVS.

8. The work shall be executed as per applicable CPWD specifications, approved norms/provisions, latest IS codes together with applicable amendments.
9. It shall be ensured that the said work is completed in all respects within the revised sanctioned amount and submit the final bill based on the actual expenditure booked along with all requisite necessary documents/certificates.

The revised sanction is issued with the approval of the competent Authority. The expenditure is chargeable to Work 2019-20.
