



**CERTIFICATE OF UNDERTAKING**

The Department of Roads & Bridges, Government of Sikkim is hereby giving the undertaking to bear the cost of raising and maintenance of Compensatory afforestation and Net Present Value (NPV) as well as the cost of protection and regeneration as per the scheme prepared by Department of Forest, Environment & Wildlife Management, Government of Sikkim in respect of diversion of hectare of Forest land for the project "Construction of Link Road from Namchi Rong to Upper Salleybong Dara Gaon in South Sikkim".

1. For public welfare schemes of non-commercial government ventures like, School, rain water harvesting, tanks, sewer lines, village roads, which are meant for public welfare, the NPV may not be charged and that in case it is finally decided by the Supreme Court that such projects are not exempted from payment of NPV, the user Agency (the Department of Roads & Bridges) will pay the amount of NPV as determined and ordered by the Supreme Court.
2. The Department of Roads & Bridges, Government of Sikkim hereby gives an additional undertaking that in case of any upward revision of rates of NPV (as per the report of the expert committee constituted by the Supreme Court and the final decision in this respect by the Supreme court) the Department will pay the amount of differential NPV.
