## {Pertaining to use of Forest Land for Construction of road from Dhaman to Khad by PWD in Mahore Forest Division}

- 1. The proprietary and legal status of Forest Land shall remain unchanged.
- 2. The Forest Land so allowed shall be utilized for the purpose for which it shall be allowed. It shall not be transferred to any other agency without approval of the Forest Department.
- 3. The Forest land so allowed shall not be mortgaged, reassigned or sub-leased by the user agency in any manner what so ever to any other agency.
- 4. I/we shall pay the Net Present Value of the land as per the orders of the Hon'ble Supreme Court of India Order dated 28-03-2008 and Order dated 09-05-2008 in I.A. No. 826 in 566 and other related I.As in Writ Petition (Civil) No: 202 of 1995 T.N Godavarman Thirumalpad V/s Union of India.
- 5. I/we shall pay Compensation of Trees according to the standard rates of 2018 .
- 6. I/we shall pay Compensatory Afforestation calculated at double the area involved.
- 7. The extraction of trees/poles shall be done by the State forest Corporation/Forest Department on the basis of markings administratively approved by the Chief Conservator of Forests, Jammu. The cost of extraction and transportation shall be borne by the User Agency.
