6. Stamp papers of Rs. 100/- each= 6 Nos. & Judicial papers 50 Nos of Rs 1/- each.

You are once again requested to deposit the extension fee amounting to Rs. 10,000/- for late submission of DPR alongwith above formalities within 21 days positively.
