This is in ref. to your letter under ref.(ii) vide which certain observations regarding Forest Proposal no. FP/MP/ROAD/156438/2022 were communicated to this office.

- 2. In this regard, the DPR Consultant vide letter under ref.(i) has submitted the compliance report. The details of same are as below:
- 2.1 The aforementioned forest proposal for diversion of forest land for subject work was submitted to concerned DFO's for diversion of total forest area of 94.5398 Ha (Khandwa-10.8093Ha & Burhanpur-84.4505Ha) based on the digital data received from Integrated Regional Office, Forest Department, Bhopal vide letter under ref(iv). Further, it is pertinent to mention that DPR Consultant was directed to to include the revenue area of Asir in the forest proposal inadvertently.
- 2.2 However, during pillar fixing/ boundary demarcation and field visit along with forest officials, the boundaries in the proposal were not matching with the compartment maps of forest department and we were advised to resubmit the proposal as per Madhya Pradesh Forest Department toposheets on 1:15000 scale.
- 2.3 Accordingly, the revenue area of Asir specified as Forest Compartment No 201 in IRO data of earlier forest proposal was removed in the revised forest proposal. Thereafter, the revised forest proposal for diversion of total forest area reduced to 87.5709 Ha (Khandwa-10.6681Ha & Burhanpur- 76.9028Ha) submitted vide letter under ref. (iii).

- Further, it is pertinent to mention that tree counting with concerned beat guard of various compartments has already been carried out from 01.08.2022 to 30.09.2022. Further, site visit along with concerned Beat Guard, Dy. Range Officer and Range officer of Khandwa, Asir, Nepanagar and Burhanpur has already been carried out from 9.01.2023 to 14.01.2023. The photographs of site visit are enclosed as Annexure-A.
- 3. In view of above, the compliance of observations raised by your office is hereby submitted for further necessary action at your end and expediting the Stage-01 approval.
- 4. Further, it is submitted the subject work is an important and prestigious work under the Bharatmala Pariyojana of Government of India and is being monitored on regular basis by PMO. It is also informed that the subject work has been already awarded and any delay in handover of forest land is bound to have financial implications for GoI which would lead to undue liabilities on public exchequer. Hence, your kind co-operation is anticipated tin public interest.
