

JOINT INSPECTION REPORT OF THE LAND PROPOSED TO BE DIVERTED FOR AUGMENTATION OF SEWERAGE SCHEME FOR MANDI TOWN AND PROVIDING SEWERAGE FACILITY TO ADJOINING VILLAGS OF MANDI TOWN IN DISTT. MANDI (HP)

We the undersigned have jointly carried out the inspection of forest land on dated 30/09 2020 required to be diverted for the **Augmentation of Sewerage Scheme for Mandi Town and providing sewerage facility to adjoining villages of Mandi Town in Distt. Mandi (H.P.)**. The location for the purpose land falls under the purview of FCA, 1980 and in the possession of forest Department, Government of Himachal Pradesh. Total requirement of Forest land are as under.

On the basis of said inspection it is certified that land in question is not effected by any burial ground or public water body like spring etc.

The inspection committee has also examined the alternative Sites/routes for the construction of Pump House, Sump well and wet well of Sewerage scheme in Mandi Town, Tehsil Sadar Distt Mandi (H.P). With a view to explore minimum use of forest land for non-forestry purpose. Seeing the site condition and to have lift the sewage system/Water to provide facilities to the people of Mandi Town, the proposal for the proposed site No-1 seem to be appropriate one as minimum trees are involved and also it being technically feasible.
