| (i) Short narrative of the proposal and project /scheme for which the forest land is required    | The proposal involves construction of link road from Dhar to Dhangar via Lunsu Rd 0/0 Km to 6/500 km in Tehsil Dehra, District Kangra within the Jurisdiction of HPPWD Dehra Division. The proposed road falls in Mohal Chakla, Chatra, Dhangar Khas, Dhar and Tilla. This road will connect the most backward villages like Dhar and Dhangar Khas with road connectivity. The proposed road has total length of 6500 m out of which 5102 m falls in forest land and 1397 m in Non Forest land. The proposal requires 4.0564 Hactare of total land comprising of 3.2180 Hactare of forest land, 0.2732 Hactare of Non Forest Land and 0.5652 ha of Private Land. |

| (iv) Justification for locating the project in forest area.                                      | The proposal needs an area of 3.2180 hectare of forest land and apart of 0.8384 Hactare of Non Forest land, there is no other suitable Non Forest land available in the alignment of proposal so maximum of components have been conceived in the forest land. Moreover the area to be connected with road connectivity is surrounded by forest land so there is no other alternative to avoid the forest land proposed for diversion.   |
