

2. Administrative Approval has been uploaded on the portal.
3. The detail note on project has been attached with the proposal folders.
4. As per Ex. Engineer NH, Division HPPWD Theog, the revenue papers containing information w.r.t. 1980 has been attached in which it has clearly been mentioned the said khasra No. Check list No. 8, was Gair-Mumkin Sadak.
5. Revised KML file has been uploaded on the portal.
6. The required detail has been attached with the proposal folders.
7. Revised Topo Sheet has been attached with the proposal folders and also uploaded online.
8. The revised Cost Benefit analysis has been attached with the proposal folders.
9. Justification for the same has been attached with the proposal folders.
10. Enumeration list of dumping site has been attached with the proposal folders and also uploaded online portal as additional information.
11. As per Ex. Engineer NH, Division HPPWD Theog, various mitigation measures will be adopted to avoid the spillage of muck into the river. Certificate attached.

13. The non-forest land coming in the alignment is of User agency and do not require any NOC/Gift deed.

14. Undertaking w.r.t. Reclamation plan has been attached.
15. Undertaking Certificate has been attached.
16. The enumeration was done on dated 07-01-2022 & 11-01-2022. The enumeration list attached already has the compartment names mentioned.
17. Needful has been done.
18. The Draft Working Plan has not prepared yet. The working circle "Chil Working Circle" will remain unchanged in the new working Circle as the area is a Chil zone.
19. Certificate w.r.t. SMC plan has been enclosed.
20. Complete CA Scheme has been uploaded on portal.
21. The status of Forest land proposed for CA is Un-demarcated protected Forest (UPF) as per 1952 Notification.
22. Correction have been made.
23. The area proposed for CA is an open forest with density less than 40%. Same has been confirmed by ground truthing. Hence, there does not seem to be any need to change or revised the CA site.
