Chamba, Himachal Pradesh.

Sir,

In reference to your office letter no. Ft. 48-5143/2020 (FCA), dated 12.12.2022, I am directed to inform you that hydro projects below 5 MW are being allotted by HIMURJA. Since this matter falls under the jurisdiction of HIMURJA matter may be taken up accordingly.

Further, with regard to criteria adopted for allotment of project, it is intimated that the project upto 5 MW capacity are allotted as per provision laid down in the policy and in accordance with the bid document approved by the competent authority.

Since, the CIA studies in Ravi Basin have not been carried out as such as and when the studies are carried out the project already allotted by the Govt. shall be required to be considered as per their allotted domains. Therefore, it shall be appropriate that the domains already allotted in this project may be considered for grant of diversion of 0.7903 hectare of forest land in favour of M/s Shiv Shakti Enterprises.

It is further intimated that in the year 2015, Ministry of Environment and Forest (MoEF), CC, GoI took in- principle decision that henceforth all the CEIA and CCS study in all River basins will be conducted by MoEF, CC, GoI itself. Accordingly, all the studies undergoing in the State of Himachal Pradesh were handed over to MoEF, CC, GoI.

In this context, it is amply clear that the mandate of such study is now with MoEF, CC, GoI, hence the matter may be taken up accordingly and diversion of 0.7903 hectare of forest land in favour of M/s Shiv Shakti Enterprises may be granted.



Sir,

In reference to your letter dated 12-12-2022, it is informed that the allotment of the projects upto 5.00 MW is being done in consonance with Hydro Power Policy provisions of Govt of H.P. and the criteria laid down in the policy, which is available on website of Himurja i.e " himurja.hp.gov.in".

As far as the matter regarding approval of sites the allotment of SHEPs are concerned , it is based on the projects identified by IPPs i.e under self identified sites /identified category. After confirming the proposals with respect to the policy guidelines these proposals were forwarded to HPSEBL & DoE for scrutiny of overlapping issues with the already allotted projects . After fulfilling the requisite criteria these projects will be allotted to the IPPs and they were asked to carryout the detailed study of the site and prepare the Detailed Project Report. After preparation of DPR the same is submitted to Directorate of Energy for its Technical Concurrence with respect of size capacity and all other aspects . As far as the cumulative impact of River basin is concerned, the matter ^{does} is not pertained to Himurja please .
