Note on violation of FCA, 1980 and action taken for violation against the diversion of proposed forest land of 10.52175 ha for development of Tourist Destination at Narikel Kunja Island, Dumboor Lake,

Dhalai District

(State SI.No.FP/TR/Others/49971/2020):

The Narikel Kunja Island is one of the tourist destinations in Tripura state situated in one Island of Dumboor Lake in Gandacherra Sub-Division under Dhalai district since long decade. The place was kept as desert as the situation was not conducive for tourists due to insurgency problem over the area for last 2 decades. Now, after becoming situation conducive over the area, the Tourism Department, Govt. of Tripura has taken initiative to develop the place for tourists under Swadesh Darshan Scheme of Ministry of Tourism (Govt. of India) as it is a Govt. priority works and accordingly the Tourism Department, Govt. of Tripura has proposed for diversion of 10.52175 ha forest land for development of tourism infrastructures as the status of land is a forest land (UGF). Accordingly the joint site inspection with user agency was carried out on 16-03-2021. During joint site inspection, it was observed that clearance of forest land, site development and some construction works have already been carried out like construction of Building portion, Sanitary installation (Toilet Block), Ticket Counter and Path way etc. measuring area of about 0.81 ha violating the FCA, 1980 unknowingly. The user agency was asked to provide name of person responsible of violation, designation and address of person responsible for violation and period of work done (years) for the said works for taking further necessary action in this regard. After a long time of about 10 months, the Tourism department has sent the name of person responsible of violation, designation and address of person responsible for violation and period of work done. The responsible person is designated as a contractor namely Shri Kashinath Bhattacharjee of Krishnagar, Agartala and the violation work carried out during 2017. Accordingly, a show cause notice was issued to the person responsible for violation or construction of works in forest land illegally. An Offence Report has been drawn (OR No.29/WLPU-GNC/2021-22) against him under Section-32 & 33 of Indian Forest Act, 1927. The details of Action Taken report as per format is attached here with.

Since the proposal under FC Act,1980 is under consideration and forest land is diverted before grant of FC, so the guideline 3.B(ii) shall be imposed which is equal to 20% of NPV for 10.52175 ha with 12% simple interest till the deposit is made.
