
Project report

The Gadchiroli Unit of Maharashtra Police has submitted the proposal to Govt. Of Maharashtra for Sanction 364 residential quarters for Police Officers and men working at There. Police Department Of Maharashtra has sanctioned 364 residential Quarters Head Quarter Pranhita as above mentioned Naxal activities are increased in this area. To Preavent and stop the naxal activities and also maintain law and order is essential to start as earliar as possible. The Police Department has explored all other possible altermative to find a suitable land repuired for construction of Proposed Building and residential quarters for Police Officers and men working At- Aheri Owing to the Law and order by naxal there is no other alternative land or site which would be selected for anti-naxal operation.

The proposed for acquisition of forest land of requires area is 19.50 hector for 364 residential quarters At- Pranhita There are no big trees and the land is free from any shurb or vegetation. As such no felling or cutting of tree will be required.




