1. Project Details:

- (i) SHORT NARRATIVE OF THE PROPOSAL AND PROJECT/SCHEME FOR WHICH THE FOREST LAND IS REQUIRED:

Energy & Power Department (Govt. of Sikkim) is entrusted to construct 19 nos. of sub-station and 29 nos of transmission lines and 08 nos of bays extension for Strengthening of power transmissions and distributions in Sikkim State for overall integrated power development which is also associated for evacuation of Power from various HEP in state of Sikkim. While in the scheme the proposal is concerned for the construction of **“LILO of 132 kV Rangit - Melli Transmission Line at LegshipPool”** on priority having a surveyed length of 2.644 km.

- (i) MAP SHOWING THE REQUIRED FOREST AREA, BOUNDARY OF ADJOINING FOREST ON A 1: 50,000 SCALE MAP

The proposed routes of 3 alternatives against each of the lines are plotted on original SOI Topo sheet of scale 1:50000 scale (1cm=0.50 km). In addition, the proposed route of the selected alignment is also plotted on traced SOI Topo sheet of 1:50000 scale (1cm= 0.50 km) for the complete length and is enclosed.

- (ii) COST OF THE PROJECT:

Estimated cost of the Project comes to Rs.1554.97Crore based on 1stquarter, 2013 price. The above estimate includes the cost 19 nos. of Sub-station, 29 nos. of Transmission lines and 08 nos. Bay Extensions. But for the above said line the estimate is approx. 19.34 crores.
