**TO WHOM SOEVER IT MAY CONCERN**

In compliance of the letter No. 11-9/98-FC(Pt.) dated 3<sup>rd</sup> August 2009 of Ministry of Environment and Forests (MoEF) Government of India wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 0.053692 hectares of forest land proposed to be diverted in favour of Bharat Petroleum Corporation Ltd. Meerut for construction of approach road of new retail out-let at NH-91(Sikandrabad - Bulandshahr Road km. 5 chainage 4.800 LB) in Bulandshahr district falls within jurisdiction of Sikandrabad Dehat village in Sikandrabad tehsil.

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.053692 hectares of forest land proposed for diversion. A copy of records of all consultation and meeting of the Forest Rights Committee(s), Gram Sabhas(s) Sub-Division Level Committee (s) and the District Level Committee are enclosed as annexure 01 to 05 annexure- 05
- b) The proposal for such diversion with full details of the project and its implication in vernacular/local language have been placed before each concerned Gram Sabha of Forest-dwellers, who are eligible under the FRA;
- c) The each of concerned Gram Sabha(s) has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of Sikandrabad Dehat Village is enclosed as annexure 01 to 05 annexure 05.
- d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- e) The Diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama Sabha have given their consent to it.
- f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.
