ITEM NO. 11: To consider and approve the proposal for Establishment of 220/132/33kV S/stn at Nagbhid, Dist. - Chandrapur.

Resolution No.116/11

C.E. (PS) placed before the Board the proposal to consider and approve the proposal for Establishment of 220/132/33kV S/stn at Nagbhid, Dist. - Chandrapur.

The Board after deliberations approved the proposal and passed the following resolution:

"RESOLVED THAT the consent of the Board of Director be and is hereby accorded administrative approval for the Scheme Report of "Establishment of 220/132/33kV S/S at Nagbhid, Dist. - Chandrapur," at an estimated cost of Rs. 14765.00 Lakhs (including IDC component of Rs. 1493.00 Lakhs) covering the following works:

1. 220kV DC line from 220kV Umred S/stn-46 Km
 - a) 220 kV MC line at MC tower - 6 kM (3 Km at Umred end & 3 Km at Proposed Nagbhid end).
 - b) 220kV DC line at DC tower- 40 Km
2. L.I.L.O of one ckt of 132kV Asgaon - Bramhapuri line at 220kV Nagbhid S/stn-21 Km
 - a) 132 kV MC line at MC tower -3 kM at Proposed Nagbhid end
 - b) 132kV DC line at DC tower- 18 Km
3. 2nd ckt stringing of 132kV Bramhapuri - Asgaon line,-27 Km
4. 2X100 MVA, 220/132kV ICT with bays
5. 1X25 MVA, 220/33 kV T/F with bay
6. 4 X 220 kV Line bay (2 nos line bay at 220 kV Umred and 2 nos at proposed Nagbhid S/S)
7. 3 X132 kV Line bay (2 Nos line bays at Proposed Nagbhid S/S and 1 Nos at Bramhpuri)
8. 33kV Outlets- 4 Nos

RESOLVED FURTHER THAT the Board of Directors be and hereby directed that while tenderizing, the scope of only 1X100 MVA ICT should be considered, however space for 2nd ICT may be kept;

RESOLVED FURTHER THAT the Board of Directors be and hereby directed that the scheme will be processed for MERC approval, for financial assistance from REC / PFC or any other financial institute/ bank and turnkey contracting procedures will be started after sanction of the scheme & availability of land;

RESOLVED FURTHER THAT the Board of Directors be and hereby directed that sufficient budget provision shall be made to complete the scheme within two year after financial tie up;


