Permission of change of land use for setting up of an Institution (Middle School) over an area measuring 6070.23 sqmt falling in Khasra no. 45//7, 14/2 in the revenue estate of village Prithla, Tehsil & District Palwal is hereby granted after receipt Rs. 1,82,107/-against conversion charges and Rs. 9,36,858/- against 10% of total EDC.

This permission is further subject to the following terms and conditions:-

- That the conditions of agreement executed by you with the Director, Town & Country Planning, Haryana, Chandigarh and the
  provisions of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act 1963 and Rules framed
  there under shall be complied with by you.
- That you shall pay the 40% of the total External Development Charges at the time of acquisition of land of this sector and balance 50% in four annual installments with 15% interest of the updated rates of EDC as existing on the date of announcement of award.
- 3. That the EDC have been charged on the basis of EDC Indexation Mechanism Policy dated 11.02.2016, which stands approved by cabinet. If there will be any change and delay in the amendment in the Act/Rules w.r.t. the said rates, then differential amount from the original calculation will required to be deposited as and when demanded by the Department.
- 4. That applicant is fully aware that the development/construction cost of 24/18/15 m wide road/major internal road is not included in the EDC rates and applicant shall pay the proportionate cost for acquisition of land, if any alongwith the construction cost of 24/18 m wide road/major internal road as and when finalized and demanded by the Director, Town & Country Planning, Haryana.
- 5. That you shall pay the additional amount of conversion charges for any variation in area at site in lump sum within 30 days as and when detected and demanded by the Director, Town & Country Planning, Haryana, Chandigarh.
- 6. That you shall give at least 75% employment to the domiciles of Haryana where the posts are not of technical nature and a quarterly statement indicating the category wise total employment and of those who belongs to Haryana shall be furnished to the G.M.D.I.C, Palwal.
- 7. That you shall get the building plans for the site approved from the Department before commencing the construction at site and will start construction within six months from the date of issuance final permission.
- 8. That you shall provide free education to at least 15% of the total strength of the children belonging to SC/BC and weaker sections of the Rural/Urban Areas of Haryana.
- That you shall obtain Occupation Certificate from the Department after completing the building within two years of issuance of this permission.
- That you shall deposit the labour cess before approval of building plans.
- 11. That you shall have no objection to acquire the land if required for road widening.

all not transfer the said permission/area for a minimum period of 3 years after grant of occupation certificate and ut to the permitted use.

rmission shall be valid for two years from the date of issue of this letter subject to fulfilment of the terms and the permission granted and agreement executed.

mission shall not provide any immunity from any other Act/Rules/ Regulations applicable to the land in question.
