This is in reference to your letter referred as (1) and our Associate Director letter referred at (2). Vide reference (1), you have mentioned that the Non-Forest Land (NFL) earmarked by Collector, Banswara vide letter No.1349-54 dated 03/04/2017, 1104 dated 21/12/2018 & 1185 dated 19/11/2019 has not been found suitable due to various reasons and hence not accepted.

In lieu of the delay in the finalisation of Non forest Land, Degraded Forest Land (DFL) of 200.10 hectare in Forest Division Jagmer Jogilal under Range Ghatol as per Annexure- C has been identified.
