**BRIEF NOTE ON THE PROJECT**

Name of the Work :        Formation of BT road from Vellimalai – Oduvanpatti for  
the length of 180m in Karumalai RF.

**LOCATION AND CLASSIFICATIONS :**

Vellimalai – Oduvanpatti road Km 1/250 – 1/430(180m) is in Pottapatti Village Panchayat of Kottampatti Block. The above road is very important one which connecting between Trichy – Madurai NH 45 Road @ Km 72/2 and Sirukudi – Thethur S4 road @ Km 9/4 Total length of Road is 9.48 Km. Now the proposed road formed in between to Vellimalai – Oduvanpatti for a length of 1.98 Km. within the Forest area is 180m (0.18 Km.) only.

**Existing feature of the road**

The existing road is cart tract with 6.00 width. The width of land available is more than 8.00m.

**Necessity : -**

This is very important Road connecting between Tiruchi – Madurai NH 45 Road at Km 72/2 and Sirukudi – Thethur SH Road at Km 9/4. This Road is Connect the Villages of Pallapatti, Silambakonepatti, Pudupatti, Lekkadipatti, Pottapatti, Guruvarpatti, Vellimalai and Oduvanpatti. This road is very useful for the public to reach educational institution of Madurai and Dindigul. The agricultural products like coconut, flowers, vegetables, cotton, fruits etc. will be transported to the near by Dindigul market through this road. Now it is an earthen road with narrow width. Hence it is very essential to form the road to standard width and improvements.

**Proposal**

It has been proposed for formation of the road to the within the Forest area is 180m. in length and 3.5m. width under Kottampatti Union General fund 2013-14.
