TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 5.5529 hectare of forest land proposed to be diverted in favour of **Power Grid Corporation of India Ltd.** for Construction of **220 KV Govindpur- Dumka Transmission Line** in Deoghar District falls within jurisdiction of Harirakha village in Sarath tehsil and Chandpur, Sarasbad, Sikdardih, Jabardaha, Chatnadangal, Madhupur villages in Palajori tehsil.

It is further certified that :

(a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire 5.5529 hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure.....to annexure.....- N.A. 
(c) the each of concerned Gram Sabha(s), has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. (d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present; - N.A. (*not Applicable*)

(e) the diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it; - N.A. (*not Applicable*)

(f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA. - N.A. (*not Applicable*)
