
Connection with the subject matter and reference cited above the following compliance is submitting herewith for further process please.

1.	The user agency in Part-I has not uploaded the kml files of the forest area of 20.82 ha required for Re-Diversion (Giddaluru Division – 5.20ha & Nandyal Division – 15.62 ha).	The Option of uploading kml files for Re-Diversion area was not available for User agency in parivesh portal. However connected hard copies of the DGPS surveyed raw data along with Kml files has been submitted to DFO/GID office Vide Lr.No.DMT-NDL/DL/Forest LA dated: 14.12.2022.
2.	The GoI, MoE&F (FC) Division in their Lr.no.8-37/94, dt.22.08.1994 and Government in G.O.Ms.no.174, E&F (For.I) Dept., dt.24.08.1994 have accorded approval under Section-2 of the Forest (Conservation) Act, 1980 for diversion of 132.31 ha of forest land for conversion of Meter gauge railway line to Broad gauge line between Giddalur and Dronachala Station in Kurnool and Prakasam Districts, subject to certain conditions mentioned there in. In this regard, it is requested to inform whether the non-forest land taken for CA purpose in Giddalur division was notified or not. If notified, copy of the same may be submitted duly informing the same.	Action may be solicited from DFO/GID
3.	The DFOs, Nandyal & Giddalur Divisions have not reported the number of tree to be felled with species wise details in the forest area required for Re-diversion over an extent of 5.20 ha. As seen from the Re-	Action may be solicited from DFO/Giddalur and DFO/Nandyal

	diversion information attached by the DFO, Nandyal, the DFO has not specifically mentioned species wise details and he informed number of trees with girth wise abstract without indicating species wise details. Hence, the same may be furnished.	
4.	Area statement indicating the fresh forest area and re-diverted area with compartment number details shall be obtained from both the DFOs and resubmit to their office for taking further action.	Action may be solicited from DFO/Giddalur and DFO/Nandyal
