As per the above tabulated record provided the land is to be transferred in favour of Jal Shakti Vibhag, Govt. of H.P. for the construction of sewerage scheme for adjoining areas of Palampur Town with capacity of 0.38 MLD, 0.95 MLD, 1.13 MLD and 0.47 MLD. The State Pollution Control Board has no objection if the said land is transferred in favour of Jal Shakti Vibhag, Govt. of H.P. subject to the following conditions:

- Prior consent of the State Board shall be obtained before undertaking any steps to establish the project under Water Act, 1974 and/or Air Act, 1981, as the case may be.
- Transfer of land shall be governed only by the regulations and provisions prescribed by Revenue Department and this NOC alone shall not entitle the applicant to purchase/acquire land.
- NOC so issued shall not confer any right on the applicant to establish the project unless the Revenue Department has actually allowed the acquisition of land.
- This NOC is subject to prior forest clearance, if any required.
- The proponent shall maintain noise level equal to or less than the standard prescribed under Env. Protection Rules, 2016 for sensitive areas near its boundary walls.
- The project shall provide proper scientific system for the disposal of domestic effluent, kitchen waste water and Municipal Solid Waste.
- During the plot leveling if any muck is generated, the same should be stored/stacked/back filled scientifically along with the provision of toe walls, as required.
