The forest land requirement villages which has more than one survey number details also requires survey number wise break up area extent. The copy of RTC of survey number, containing mutation in favour of the Forest Department in respect to the forest area proposed to be diverted needs to be provided. 	<ol style="list-style-type: none"> Since the proposed approach road is situated in Donimalai Forest Block of Narayanapura village survey numbers are not available. And For Bandravi Village Survey Numbers wise mentioned in break up column and correction has been done in the column. Survey Numbers wise details and breakup wise extent have being done in the column. The proposed road is situated in Donimalai Forest Block of Narayanapura village RTC Copies are not available. And For Bandravi Village Survey Numbers RTC Copies attached in the Additional information column along with proposed approach road required for diversion.

Cross section of approach road with components is attached in the Additional information column.</p>

<ul style="list-style-type: none"> Four segments KML files are uploaded with generic names; 'Segment -1,2,3,4' showing total area extent as 2.695 ha as against 2.67 Ha mentioned under Bellary division. One segment KML file is uploaded with generic names; "Segment -5' showing total area extent as 4.178 ha as against 4.165 Ha mentioned under Chitradurga division. Total area extent under both Divisions is 6.873 Ha as against 6.83 Ha. Non forest land requirement KML is not provided. The provided alignment abruptly ended in middle of RF boundary and again started from the middle of the RF boundary. Hence the Complete project ' alignment running in forest as well as non-forest land needs to be shown on maps to ensure that forest land is not mistaken as non-forest land for the purpose of the project. 	<ol style="list-style-type: none"> Four Segments of KML with 'Segment 1,2,3,4' showing total area of 2.686 Ha is now corrected and mentioned under Bellary division. One Segments of KML with 'Segment 5' showing total area of 4.149 Ha is now corrected and mentioned under Chitradurga division. Total area of both Divisions is 6.835 Ha is now corrected. Non-Forest Land requirement KML is uploaded now. The Complete project alignment running in forest as well as non-forest land are shown in the Georeferenced Map and The Village Map Corrected Copy uploaded in the said column.
