
As per Joint survey Conducted on dated 15.09.2021 with Divisional Forest Officer, Bhadarwah, Revenue officials Doda, NHIDCL(User Agency) and Rodic Consultants Pvt Ltd (DPR Consultants) and its representative & revenue paper (Land Acquisition Plan) prepared by revenue officials and verification letter from DC cum CALA, Doda vide 497-502/LAC/D/21 dated 09.09.2021 and 3(D) of NH-Act 1956 vide Gazette of India Notification vide S. O 3886(E) dated 20.09.2021 found forest land of 3.2549356 Ha. to be diverted for non-forest purpose in favor of General Manager (P), National Highways and Infrastructure Development Corporation Limited (NHIDCL) for Construction and Upgradation of road from design Chainage 31.449 (Khellani, Pariyot) to Km 51.700 (Prem Nagar) (Design length 20.251 Km.) in the Union territory of Jammu and Kashmir Package-1 of National Highway Number 244.
