A proposal has been received by this office from Project Director, NHAI, PIU Palampur, District Kangra (HP) - 176061 for diversion under FCA-1980 of 2.0441 hac. of forest land in Dharamshala Forest Division for non-forestry purpose. The project envisages the use of forest land for Rehabilitation and Up-gradation to Four Lane Configuration & Strengthening of Sihuni to Rajol (Package IIA) from Km 51.00 to Km 72.00 (Design Length 18.450 Km) of NH - 20 (New NH - 154) of Pathankot - Mandi Section District Kangra (H.P.). The site inspection of the land involved in the proposal has been done by me on date 21-07-2023.
