With respect above subject and reference our FC Pro Posal vide FP/KA/OFC/155716/2022 for diversion of 0.5569ha. At the time of FC proposal submission in Parivesh.1 the Vijayanagar Division was not reflecting in Parvesh portal, hence after discussion with FC, PCCF combined proposal for Bellary & Vijayanagar submitted and the Wilf Life proposal for same is already cleared by State Board for Wild Life hence it is requested to process proposal in PArviesh.1.

Regarding short comings noticed in your above reference are clarified as below.

- a. Combined proposal for Vijayanagara & Bellary Foest Divisions as already been submitted in Parviesh.1 because Vijayanagar Division the Vijayanagar Division was not reflecting in Parvesh portal.
- b. As per ACF report in Sandur Taluk, Chornur Sy. No. 578 and Kduligi Taluk, Appenahalli Sy. No.1 details is corrected in Parvesh.1 port part-1.
- c. Chornur and Appenahalli correction have been made and the in-area statement is uploaded.
- d. FC proposal for laying of underground OFC all along the road with in the RoW of road width and the necessary permissions from Executive Engineer PWP and IWTD Division Bellary it is already submitted in Parivesh portal this is for your information.
- e. Clear and corrected topo sheet submitted in Parivesh portal.
- f. Because village maps contains many tikkas as per the scale may not possible to accommodate all the tikkas in village map scale. Hence combining all the tikkas in one map for showing alignment may kindly be accepted for the processing of the proposal.
