We also undertake to deposit the said additional cost to the concerned authorities of Forest department as advised, in-respect of the project "Proposed Diversion of Forest land to an extent of 0.571HA (1.41Acres) in RF Station of Kondiagudem of Manuguru Division, Bhadradri Kothagudem District for laying of 1200 mm diameter MS pipe line from Intake well to Raw water Reservoir at Bhadradi Thermal Power Station Manuguru, Bhadradi Kothagudem District".
