5. उक्त कार्य करने में 212 वृक्ष तथा 144 अण्डरसाइज के पौधों भी बाधित हैं जो कि सी०ए० स्कीम में शामिल कर लिये गये हैं।
6. सी०ए० स्कीम बाधित वृक्षों के 10 गुणा अनुसार बना दी गई है।
7. पार्ट-2 में बाधित वृक्षों की संख्या 212 दर्शा दी गई है।
