
SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF / DFO

A proposal has been received by this office from **Project Director, NHAI, PIU Palampur, District Kangra (HP) - 176061** for diversion under FCA-1980 of 5.2021 hac. of forest land in Nurpur Forest Division for non-forestry purpose. The project envisages the use of forest land for **Rehabilitation and Up-gradation to Four Lane Configuration & Strengthening of Sihuni to Rajol (Package IIA) from Km 51.00 to Km 72.00 (Design Length 18.450 Km) of NH – 20 (New NH – 154) of Pathankot – Mandi Section District Kangra (H.P.)**. The site inspection of the land involved in the proposal has been done by me on date **27-01-2023**

2. On inspection of the site, it is found that the land required by the user agency is a forest area measuring 5.2021 hac.
3. The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project.
