#### **AUTHORISATION LETTER**

The project named "KARNATAKA URBAN WATER SUPPLY MODERNISATION PROJECT (KUWSMP)" Diversion of 0.19477 hectare of forest land in FRS No.30 in Rayapur Village of Taluka & District Dharwad for KUWSMP 24X7 Water Supply Project to Hubballi-Dharwad City. To lay Clear Water Transmission main (1219, 864,762 & 250 mm Diameter) MS & DI pipes from proposed Water Treatment Plant at Amminabhavi to various service reservoirs in favour of commissioner, Hubballi-Dharwad Municipal Corporation, Hubballi.

After detailed study of the topography and hydraulic feasibility for laying of Clear Water Transmission Main of MS 1219 from WTP to Rayapur, 864 from Saraswathpur to Rayapur, 762 from Rayapur to Tarihal and 250 from Rayapur to Rayapur village. And other Over Head Service Reservoirs of Hubballi-Dharwad Cities at various locations in the city are identified and hydraulic model is finalized. Based on the hydraulic suitability to provide continuous 24X7 pressurised water supply to Hubballi-Dharwad cities. Over Head Service Reservoirs are to be feed from Amminabhavi Water Treatment Plant the proposed clear Water Transmission Main Pipe line alignment as per Topography and Hydraulic feasibility the alignment passes through the Reserve Forest.
