BANK GUARANTEE

1. In consideration of agreement for laying O. F. C. along the route Bathinda- Muktsar, Malod- Abohar for Section From Bathinda Muktsar Malout to Dodewala to Rajpura Beriar to Abohar Baipass, to Hunmangarh Baipass Malout to Abohar Road Total Length 85210mtr In the State of Punjab between Divisional Forest officer Sri Muktsar Sahib. Pin Code 152 026 (hereinafter called the Principal) and head projects "Reliance Jio Infocomm Limited, 9th Floor, Maker Chambers IV, 222, Nariman Point, Mumbai - 400021, India." (hereinafter called Contractor) We, ICICI Bank Ltd, a schedule bank in India incorporated under the Provisions of the Companies Act, 1956 and having registered office at Near Chakli Circle, Old Padra Road, Vadodara-390 007, India and having a branch office at ICICI Bank Ltd, Ground Floor, Building, 4, A Wing, Rcp, Nocil Compound, Thane Belapur Road, Ghansoli, Navi Mumbai.400701, India hereby undertake to pay the principal an amount not exceeding Rs.2130250/- (Rs. Twenty one lac thirty thousand two hundred fifty only) against any loss or damage caused to or suffered or would be suffered by the principal, by reasons of any breach of the terms or conditions contained in the said agreement.

2. We, ICICI Bank Ltd., do hereby undertake to pay the amount due and payable under this guarantee without any demer, merely on a demand from the principal stating that amount claimed is on account of not making good and executed trench for laying of underground cable of proper filling and compaction, as to restore the land in the same condition as it was before digging the trench, debris loose earth produced due to execution of trenching. However our liability under this guarantee shall be restricted to Rs. 2130250/- (Rs. Twenty one lac thirty thousand two hundred fifty only). We undertake to pay the principal any money so demanded notwithstanding any dispute or disputes raised by the contractor(s) in any suit or proceeding pending before any court or tribunal relating there our liability under this present being absolute and unequivocal. The payment so made by us under this bond shall be a valid discharge of our liability for payment there under and the contractor(s) shall have no claim against us for making such payments.

3. We, ICICI Bank Ltd., further agree that the guarantee herein contained shall remain in full force and effect during the period would be taken for the performance of said agreement and that it shall be continued to be enforceable till all the dues of the principal or by virtue of the said agreement have been fully paid and its claims satisfied or discharged or till the principal certify that the terms and conditions of the said agreement have been fully and properly carried out by said contractor and accordingly discharges this guarantee or till 02-01-2018, whichever is earlier, we shall be discharged from our liabilities under this guarantee thereafter.
