Subject: Proposal for the Permission for laying of underground gas pipeline of M/s Indraprastha Gas Limited, from Ch:102.050Km (RHS) to Ch:113.440Km (RHS) for 12" Dia Steel Pipe and 125mm Dia MDPE Pipe and from Ch:122.200Km (RHS) to Ch:128.500Km(RHS) for 8" Dia Steel Pipe and 125mm Dia MDPE Pipe, across the National Highway at 08 number of locations. The total section length for ROW applied is 17.69Km on along National Highway (Delhi Muzaffarnagar Road), NH- 58 (New NH-334), in the State of Uttar Pradesh.

Sir,

The approval of the Competent Authority is hereby conveyed for laying of underground gas pipeline from Ch:102.050Km (RHS) to Ch:113.440Km (RHS) for 12" Dia Steel Pipe and 125mm Dia MDPE Pipe and from Ch:122.200Km (RHS) to Ch:128.500Km (RHS) for 8" Dia Steel Pipe and 125mm Dia HDPE Pipe, across the National Highway at 08 number of locations. The total section length for ROW applied is 17.69Km on along National Highway (Delhi Muzaffarnagar Road), NH-58 (New NH-334), in the State of Uttar Pradesh, subject to the following conditions:


- (i) The crossing/laying will be done as per the proposed/ agreed location route and as per proposed layoutplan.
- (ii) The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
- (iii) Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S6R(R) dated 22.11.2016.
- (iv) Undertaking to the following effect may be taken from the applicant and made part of the agreement: -
 - (a) Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
 - (b) The permission may be terminated immediately on violation of the agreed terms & conditions.
 - (c) The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.

- (d) Ensure that the submitted Agreement is in prescribed format as per Ministry circular No. Circular No. RW/ NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant and BG be obtained as per the Circular.
- (e) Work programmed from the Applicant may be obtained and ensure timely completion.
- (f) The compliance of various undertakings given by the Applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of NHAI and safety of road users.
- (v) Laying /crossing work should be carried out through HDD method only.
- (vi) It shall be the responsibility of the Applicant to ensure the Safety and maneuverability of Highway Traffic during laying of Gas Pipeline.
- (vii) The approval is based on the submissions made by the Applicant. The Applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (viii) In view of any future development requiring necessary alteration, including complete removal, or shifting of the Gas Pipeline, the same shall be carried out by the Applicant at its own cost to the satisfaction of the Highway Administrator.
- (ix) In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- (x) IRC: 98-2011 be complied wherever applicable.


