Respected Sir,

With reference to the letter cited above, the short coming found in the diversion proposal has been complied herewith. The details furnished are given below:

1. Tree enumeration list of both forest & non-forest land has not submitted.

The tree enumerated is in land of tropical dry deciduous Forest in degraded condition. The report comprises of (Sal) Shorea robusta (Asan) Terminalia tomentosa (Kendu) Diospyros melanoxylon (Char) Buchanania lanzan (Mahul) Madhuca indica (Bheru) Chloroxylon swietenia (Palas) Butea monosperma (Kurei) Holarrhena antidysenterica (Dhatki) Woodfordia fruticose (Khakada) Casearia elliptica/tomentosa (Sidha) Lagerstroemia parviflora (Amla) Emblica officinalies (Kochila) Strychnos nux-vomica (Dharua) Anogeissus Latifolia and others. The density is 0.2 for both Reseve and Revenue Forest. A total of 23635 nos. of trees in Forest Area and 363 nos. of trees in Govt. Non-Forest Area have to be felled during the commencement of the project in a phased manner. In compliance to the above, the duly authenticated tree enumeration list of both forest & non-forest land is being submitted in **Annexure-I** in Hard &Soft copy.

2. Cost Benefit analysis as per latest guideline has not submitted.

The Cost Benefit analysis report as per the latest guideline has been prepared. The cost benefit ratio for the proposed Kulda Expansion OCP (21.00 MTPA) comes to an estimate of 1:76.04. The report is hereby submitted in **Annexure-II** in Hard & Soft copy.

3. Compensatory afforestation land along with DGPS survey with KML file has not submitted.

The land for Compensatory Afforestation was issued by the DFO, Sundargrarh, vide no.-1663, Date – 28.03.2022, where the area of 305.59 Ha of Punjipahad RF (131.54 Ha), Pandripani RF (64.10 Ha), Panikholia RF (56.39Ha), & Sidarmunda RF (53.56 Ha) of Gaplapur range was allocated for CA against the diversion proposal of 134.69 Ha of Forest Land for Kulda Expansion OCP. The actual area after DGPS is 311.848 Ha which has been communicated by ORSAC to DFO Sundargarh vide letter no. – ORSAC/DGPS-FD/1084/2022/3421(2), Date- 15.09.2022. The copy of authenticated DGPS Survey with KML file has been attached in **Annexure-III** in hard & soft copy. It is requested to provide the CA Scheme for the allotted land for further course of action.

4. As per land schedule the total area of forest, non-forest & tenancy land is not correct.

The details of area under existing land use of Kulda OCP (21.00 MTPA) in a total area of 634.205 Ha is given below:

The diversion proposal is based on the land requirement as shown in table no. -2, 3 & 4. This clearly shows that there is no difference in the land schedule and the proposed additional land requirement. Hence, it is submitted that there is no difference in the proposal and the land schedule regarding land requirement. The only difference that is arising, is because of diversion of 8.52 Ha out of 227.89 Ha in the existing land use of Kulda OCP to Basundhar Washery which has been clarified in table no.-5. Hence, the total Land (includin the existing land) required for Kulda Expansion OCP (21 MTPA) as per approved Mining Plan in Revision -4 is as given below:

The present diversion proposal is for 134.69 Ha which is fresh in nature and there is no difference in the land schedule (attached in **Annexure-V**) and the proposal. Hence, it is submitted to consider the forest diversion proposal of 134.69Ha for Kulda Expansion OCP (21.00 MTPA) for further onward processing.

5. Additional Documents submitted by PP w.r.t. the Diversion Proposal

a. Mining Plan:

The Mining Plan has been revised from 18.75 MTPA to 21.00 MTPA, as Kulda OCP has obtained an Environmental Clearance for a capacity of 21.00 MTPA, issued by MoEF&CC vide no. – F No. J-11015/10/1995-IA-II(M), Date – 24.05.2022, (copy enclosed in **Annexure-IV**). Hence the revised and authenticated Mining Plan (21.00 MTPA_Revision-4) with respect to Kulda Expansion OCP is being submitted in **Annexure-VI**.

b. Authorization Certificate:

The Project Officer of Kulda OCP has changed. The present authorized Project Officer of Kulda OCP is Shri. Manoranjan Das. The Authorization Certificate has been attached in **Annexure-VII** and now onwards Shri Manoranjan Das, the Project Officer of Kulda OCP will make all applications related to Forest Clearance on behalf of MCL.

The 8.52 Ha out of already diverted 227.89 Ha forest area for Kulda OCP (existing) has been rediverted to Basundhara Washery, vide no.- 8-176/1997-FC (Vol.), date – 11.03.2019 (Copy enclosed in **Annexure-VIII**). The mine has not totally de-coaled its existing land. The mine has uppermost Lajkura seam which is being excavated leaving Rampur and Ib seam in the lower.

Excavation is under progress in all the three seams, but backfilling is concurrently being done on the de-coaled area as well as used to increase the existing dump height as per the approved Mining Plan. Therefore after final decoaling, backfilling and biological reclamation will be carried out as per the approved Mining Plan of 21 MTPA (including 134.69 Ha of Forest Land) and then the process to handover the reclaimed area to Forest Department will be started. Further the status of reclamation as on date -03.10.2022 is as follows:

d. The status of compliance of Stage-II Forest Clearance of 227.89 Ha:

The area of 8.52 Ha which was re-diverted out of 227.89 Ha has only the Stage-I clearance, and stage –II clearance is yet to be obtained, hence the status of stage-II compliance of 227.89 (F.No.- 8-176/1997-FC, Date – 08.08.2007) Ha is being submitted in **Annexure-IX**.

e. Status of maintenance of Safety Zone:

Infrastructure including Safety Zone (7.5m around mine boundary) and Embankment excluding 8.52 Ha is in an area of 28.095 (provided in table-6). The safety zone area is retained for future expansion. A total of 18414 nos. of plants have been planted over safety zone area and thick lush green belt has been developed which is being maintained as green cover over the safety zone area (7.5m around the mine boundary).

Besides this, compensatory afforestation has already been raised in 459.01 Ha at the project cost for Kulda OCP in Kumkani R.F. (455.78Ha) & Dhangergudi R.F. (3.23Ha) including Safety Zone.

f. Coal Evacuation Plan:

The undersigned hereby submits the coal evacuation plan (in Annexure - X) for mining activity as proposed for 21.00 MTPA in 295.62 Ha, as per the approved Mining Plan attached in Annexure-VI. The mine has already obtained Environmental Clearance for a production capacity of 21.00 MTPA and the proposed area shall be utilized for a production capacity of 21.00 MTPA for 11 years. It is undertaken that the environmental pollution control measures will be taken as per the EIA/EMP report for the 21.00 MTPA capacity.
