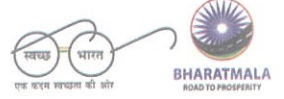

Sir,

This is with reference to 7th Meeting of Project Screening Committee, Haryana held on 27th January, 2023 through VC under chairmanship of Adll. PCCF-cum-Nodal Officer regarding Forest Clearance. The proposal under subject above was also discussed at Agenda Item No 5.8 in the said meeting.

2. During the discussion, following two observations were made by the Project Screening Committee:

- NOC of Railway and Irrigation Department regarding proposed forest land.
- Correct KML file along with DGPS Map needs to be corrected. GPS points needs to be provided for all vertices/ corners of the polygon.

3. In this regard, it is informed that:

- Conceptual plan of ROB has been approved by Railway Department and Irrigation Department has raised the demand note for processing the NOC. NHAI has initiated payment of the demand note. The same may be considered as provisional NOC of Railway and Irrigation Department for In-principle Approval (Stage-I Forest Clearance). It is worth mentioning that NHAI has already provided undertaking for obtaining NoC from the concerned department i.e., Railway & Irrigation and uploaded on Parivesh Portal.
- KML file has been corrected along with DGPS Map and the corrected one has been uploaded on Parivesh Portal.

4. In view of above, it is requested to process the NHAI's proposal for obtaining the In-principle approval (Stage-I Forest Clearance) at the earliest please.
