In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No.11-9/98-FC (pt.), dated:3rd August, 2009, wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February, 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 13.2653 Hectares of Forest land in Nalgonda Division, Dameracherla Mandal, Veerlapalem Village, proposed to be diverted in favour of Chief Engineer, Civil, Thermal, TSGENCO, Hyderabad (name of the user agency) for construction of Railway Line from Vishnupuram Railway Station to TYPs & Raw Water Intake Structure on U/s of NagarjunaSagar Tail Pond dam including laying of raw water pipeline from river Krishna to YTPs (purpose for diversion of forest land) details are as follows:

- (c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.







The Chief Engineer / Construction, YTPS, vide LR.No.CE/Constn/Se/C/CC-1/YTPS(5x800MW)/F/Revenue Lands / D.No.1088/2021-22 Dated: 03.03.2022 has requested to arrange to issue RoFR Certificate in Format -I for an extent of 13.2653 Hect of Forest land to be diverted in favour of TSGENCO for construction of Railway line from Vishnupuram Railway Station to YTPS, Veerlapalem (V) Dameracharla(M) and Raw water Intake structure on U/s of Nagarjuna Sagar Tail pond dam including laying of raw water pipeline from Krishna river to YTPS for onward submission of proposal to the Government for further processing of diversion of Forest land in the name of YPTS / TSGENCO.

The proposed forest Land located in Nalgonda District, Dameracharla Mandal, Veerlapalem (V) and the matter was examined and there is no claims under "Scheduled Tribes and other Forest Dwellers (RoFR Act, 2006) in proposed Forest Area.
