



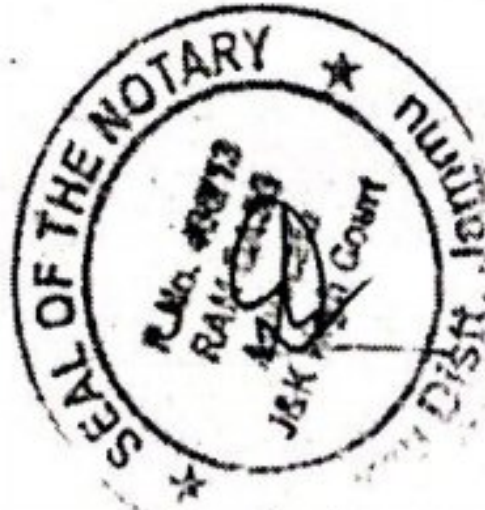

In this regard, please find enclosed certificate issued by ARMY for ROW permission.


