- It is to inform you that NOC for laying of OFC is hereby issued with following conditions as per MOU signed with DGBR.
- Laying of OFC should be done only by HDD method as per standards, polices and guide . (a) lines laid by OFC authority.
- The cable shall always be laid at the edge of RoW in case of restricted width of the ROW. (b) which may be adequate only to accommodate the carriageways central verge shoulders slopes of the embankment and drains, the cables shall be laid beyond the toe line of the embankments and clear of the drain. In cases where cable / ducts with sufficient space are already available along NH. the cables shall be laid in such ducts subject to technical requirements being fulfilled.
- The top of the casing/conduit pipe containing the cable shall be at least 1.2m below the top (c) of the subgrade or the existing ground level whichever is lower subject to being at least 0.3m below the drains inverts. Deviation required in achieving the minium depth, if any, shall be granted if found reasoned. Any structure above grund shall be aesthetically provided for/landscaped with required safety measures as directed by the concerned authority.
- The restoration work will be carned out by the Licensee alongside the OFC execution work stretch wise. On completion of the restoration work, a joint inspection of the restored route will be carried out by the representative of the Authority and the Licensee to ascertain its quality. On successful verification, clearance will be given by the Authority for further stretch wise OFC execution work by the Licensee.
- In case the quality of restoration work is not as per MoU, BRO through a Board of officers will assess the additional quantum of work required for proper restoration based on DGBR SSR and shall execute the restoration work, by encashing the Bank Guarantee deposited by Licensee.
- The Authority shall recover money by encashing any Bank Guarantee of Licensee or restoration of any stretch of road for which RoW permission is granted. On encashing of the Bank Guarantee by the Authority, the Licensee will recoup the Bank Guarantee to Rs 25 Croes within 30 days of receiving the intimation.
