Later, based 07/07/2021 and 27/04/2022 guidelines of MoEF, we appealed before the MoEF to consider the proposal for transfer of FC instead considering for Stage — I which has been in principally agreed in agenda 4 of File No. 8-21/2021-FC dated 23/12/2021. Hence, the proposal was placed before the FAC on 15/07/2022 in which PCCF (FC) Nodal Officer (FCA) has raised not to consider the proposal of MSPL Limited for transfer of FC as the CA land mutated was a forest land. Thus, the matter got struck neither for transfer nor for fresh FC as Stage - I.

We tried to convince him that, lot of changes in the statue have taken place subsequent to 1895, after independence of India, reorganization of States, merger of Sandur Princely State, formation of Mysore State and finally now Karnataka as State. All other series of documents other than 1895 notification depicts that, the Sy. No. 563 as revenue land mutated to forest department.

Cabinet of Government of Karnataka has ordered for taking back the revenue C & D land from the forest department to create the Land Bank vide order RD/106/LGP/88 dated 03/01/1991. The hand over and take Over certificate Number CUM/Bhoomi/258/1991 dated 15/03/1991 is a best evident for it. The Sy No 563 is also one of the survey number taken back from forest to revenue department for Land bank purpose.

M/s. H G Rangangouda has obtained the Permission from The Deputy commissioner, Bellary for Survey Number 563 to an extent 161.25 acres as CA land vide Dy. Commissioner, Bellary order Number: 332/Bhoomi/1991 dated 11/02/1992. Deputy Commissioner, Bellary has ordered for the mutation of the said survey number 563 over an extent 161.25 acres in favour of forest department vide order number CUM/Bhoomi/C&D/03 2019 dated 13/11/2019.

We also bring your kind knowledge that, several user agency have suffered a lot due to wrong presumption of PCCF (FC) Nodal Officer (FCA) over CA land hand over by the several user agencies including MSPL Limited. This has been recorded in the recent minutes of proceedings dated 29/06/2022 in which forest department has agreed and directed the revenue department to identify the C & D land in the case of 5 mining lessees, since these lease holders are not at fault but lost the CA land status due to irregularities noticed in Kolar district. copy of proceedings is enclosed herewith for your ready

Subsequently, the Company has applied for Forest clearance and the proposal has been recommended from Government of Karnataka to MoEF, SZ on 30/09/2020 and the said proposal has been further forwarded to MOEF, New Delhi on 23/12/2020.

MoEF, New Delhi has raised query on 23/12/2020 and after being satisfied with the reply made by the State Government, our proposal has been cleared in the FAC, but the Stage – I order was pending. This has been recorded in the recent minutes of proceedings dated 29/06/2022 in which forest department has agreed and directed the revenue department to identify the C & D land in the case of 5 mining lessees who have lost the CA land status due to irregularities noticed in Kolar district.

Eventually, revenue land handover in favour of HG Rangangouda was done 3 decades back. Forest department has accepted the same till 15/07/2022. Raising an objection at this stage over new user agency is an harassment over MSPL Limited. We submit before you that, successful bidder need to commence the mining operations within 18 months of LOI being issued by the Director Mines and Geology. Due to wrong claim made by the PCCF (Forest), our proposal for transfer of Forest Clearance got struck before MoEF, New Delhi. In view of the above we are of the opinion that, the said land is a revenue land and therefore request you to direct the forest department to write to MoEF that, the said land was a revenue land and has

Proceedings of the meeting held under the chairmanship of Hon'ble Minister of Forest, Food and Civil Supplies at Aranya Bhavan on 29-06-2022 at 11.00 AM to discuss the cancellation of non-forest lands provided for CA in Kolar Taluk, Kolar District.

Present in the meeting:

- 1. Hon ble Minister of Forest, Food and Civil Supplies.
- 2. Additional Chief Secretary, Forest, Ecology and Environment, Department
- 3. Principal Chief Conservator of Forests (Head of Forest Force) 4. Principal Chief Conservator of Forests (Forest Conservation)
- 5. Chief Conservator(s) of Forests, Ballari and Bengaluru Circles
- 6. Deputy Commissioner, Kolar District
- 7. Deputy Conservator of Forests, Kolar and Ballari Divisions

The Principal Chief Conservator of Forests (Forest Conservation) welcomed the Hon'ble Minster and officers present in the meeting and briefed the purpose of the meeting that the matter pertains to cancellation of CA lands by the Assistant Commissioner, Kolar District which were earlier given as CA lands against certain leases,

Deputy Conservator of Forests, Ballari Division provided the detailed list of leases for which these CA lands were identified (Copy enclosed) and subsequently cancelled.

During the discussions it was brought out that, at the time when these CA lands were given, they were identified from out of revenue lands as per the then prevailing norms. However, now as per Government of Karnataka Order No. FEE 88 FLL 2016 dated 31-08-2016 all the private lease holders have to purchase lands from the private parties for the purpose of providing CA fand. In all of these cases, the CA lands have been cancelled by the revenue authorities as the first allotment liself was wrong. However, since these lease holders are not at fault, a suitable decision needs to be taken as to how to recoup the loss of CA lands due to the cancellation.

a and other to senten it was decided to explore the possibility Revenue land to an extent of 200 ha for making good the CA land already lost due to cancellation for the following leases only: -

1) M/s Lakshmi Minerals ML No. 2551 - 24.51 ha.

2) M/s Veerabhadrappa and Sangappa Company ML No. 2160-3.373 ha

3) M/s Balasubbashetty and Son ML No. 2502 - 3.14 ha

4) M/s Nadeem Minerals ML No. 2526 - 12.81 ha

5) M/s M. Srinivasulu ML No. 2552 - 134.00 ha

It was noted that as regard other leases viz M/s H.N Prem Kumar, M/s Chowgule and Co., M/s SMIORE and M/s Zeenath, they have already provided Revenue land in other areas prior to 2016.

For some, the leases have expired and are yet to be auctioned viz, M/s Veeyam and M/s Vibhutigudda. M/s Anjaneya is a fresh proposal. M/s Kanhaiyalal, M/s H.G Rangan Gowda and M/s Narayana mines have been auctioned recently to new lessees. Hence, here the new lessees will be asked to provide fresh CA land.

After detailed deliberation on the subject, the Deputy Secretary, Revenue Department and Deputy Commissioner Kolar ware asked to identify suitable Revenue land for the above five mining leases to an extent of 200.00 ha and intimate early for taking further action.


