> Sub:- Request for area correction based on DGPS Survey in Forest Clearance proposal (No.FP/CG/MRL/5/2016) for prospecting in 1745.883 Ha of forest land under Forest Conservation Act 1980 in Kente Extension Coal Block of Rajasthan Rajya Vidyut Utpadan Nigam Ltd (RVUN)

Dear Sir,

This is in reference to your above referred letter dated 03.02.2017 vide which justification was sought for the difference in the prospecting area (i.e. earlier applied area 1759.04 Ha and revised area of 1762.839 Ha) in respect of Kente Extension Coal Block of Rajasthan Rajya Vidyut Utpadan Nigam Ltd (RVUN).

In this regard, it is intimated that the difference in prospecting area wrt earlier applied area 1759.04 Ha and revised area of 1762.839 Ha is due to the following reasons;

1. While uploading the online registration proposal for Forest Clearance for Prospecting License, the total area for block boundary was mentioned as 1759.04 Hectares and the forest area as 1742.15 Hectares based on the coordinates supplied by CMPDIL vide letter dated: 16.12.2015. Accordingly, the online registration for Forest Clearance for Prospecting License was completed for the area of 1759.04 Hectares.

2. CMPDIL later issued revised coordinates for Kente Extension coal block boundary vide letter dated: 17.03.2016. Subsequently, First Amendment to the CBDPA for Kente Extension Coal Block between RVUN and Ministry of Coal, Govt. of India in this regard was executed on 10.08.2016. DGPS Survey was thereafter conducted as per the directives of Nodal Officer, Raipur where the exact area of the Kente Extension Coal Block was revised to 1762.839Ha. with the forest area of 1745.883Ha.

3. FMIS Maps were issued where the area and coordinates of the coal block as per the DGPS Survey Report were also certified by forest officials by conducting field inspection. The revised area of 1762.839Ha. was also recommended by the State Government vide letter No.F 3-24/2013/12, dtd: 09.01.2017 seeking in principle approval from MoC under sec 5(1) of MMDR Act 1957.

4. All certified maps and documents for prospecting in an area of 1762.839Ha. (Including forest area of 1745.883Ha.) for Kente Extension Coal Block in 6 sets of hard copies were also submitted to your good office on 06.01.2017.
