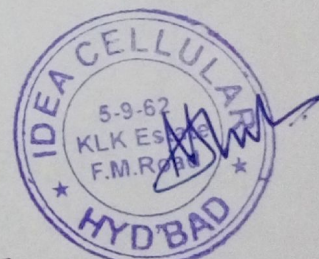

## CERTIFICATE FOR COMPENSATORY AFFORESTATION

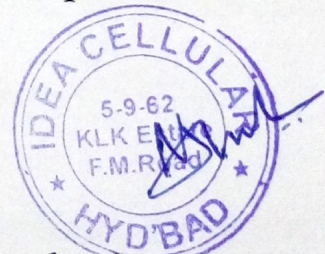



## PROJECT APPRAISAL

M/s.
