

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (Pt.) dated 3rd August, 2009 wherein the MoEF issued Guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (FRA, for short) on the forest land Proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, It is Certified that **4.158** hectares of forest land proposed to be diverted in favour of Superintending Engineer, TDWSP,(RWS&S) Circle, Nirmal for construction of structures and laying of Pipelines in (Asifabad & Wankidi) Segment No-22/9 of Asifabad Range in Adilabad district falls within jurisdiction of Ada, Chirrakunta & Yellaram in Asifabad mandal and Indani, Velgi & Kannergaon in Wankidi mandal.


