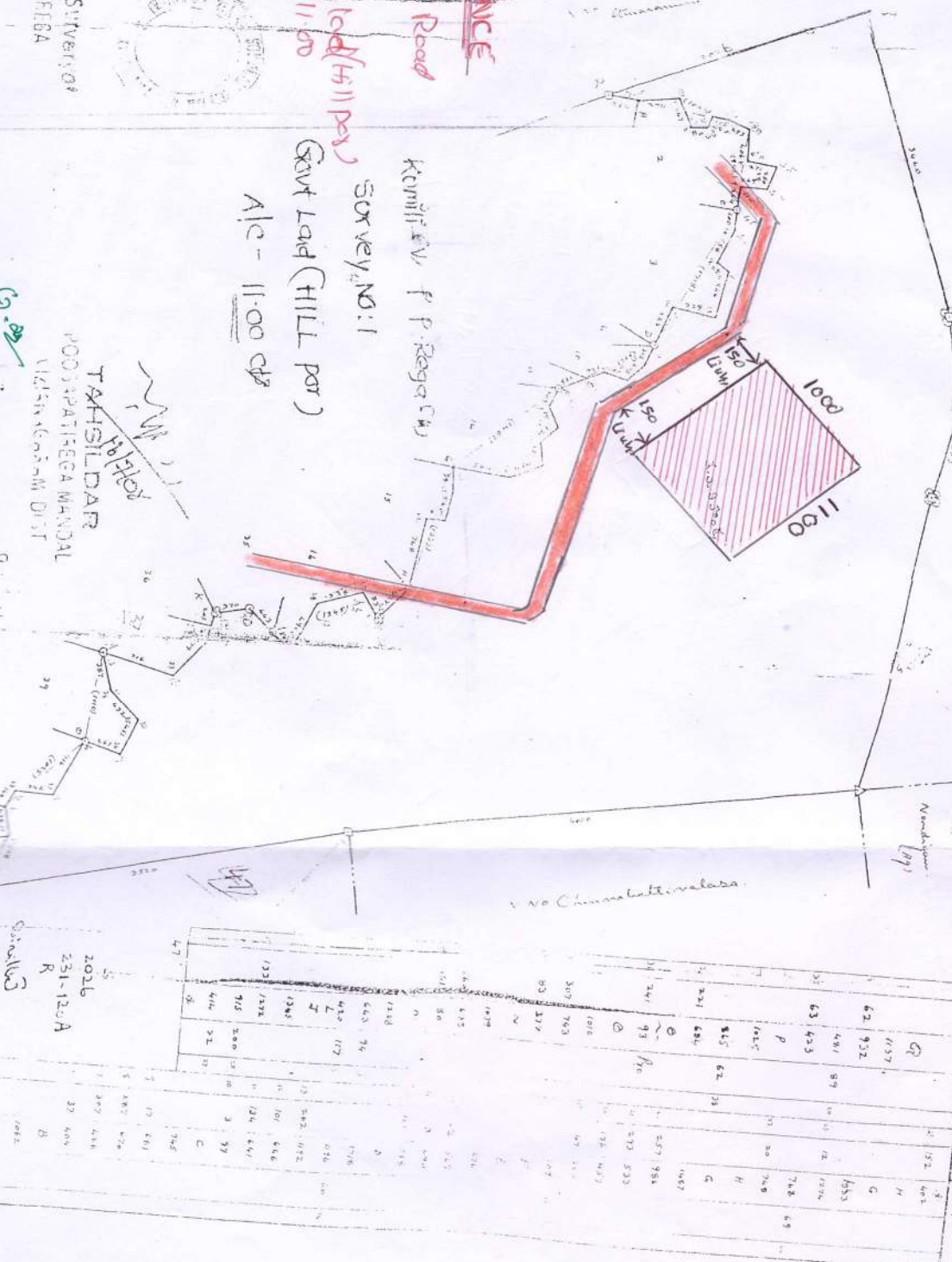

I invite Kind attention to the references cited.

In the reference 1st cited, proposals has been received from the Revenue Divisional Officer, Vizianagaram for transfer of Ac. 11.00 Cts (4.42 Ha) of Government land in Sy.No.1 of Kumili Village of Poosapatirega Mandal to the Executive Engineer, TRTS Project, Vizianagaram for the purpose of in turn transferring the said lands to Forest Department, Territorial Forest Division, Vizianagaram in compensation to the Forest lands utilized in TRTS Project for excavation of Tunnel, across Damarasing Reserve Forest hill range (Gurla Mandal).

In the reference 2nd cited the Revenue Divisional Officer, Vizianagaram has been requested to submit detailed report with supported documents, requisition of I & CAD Department, specific remarks and recommendations to take necessary action in the matter.

In the reference 4th cited the Revenue Divisional Officer, Vizianagaram submitted report stating that the Tahsildar, Poosapatirega reported that the Executive Engineer, TRTS Project, Vizianagaram has submitted alienation proposals stating that an extent of 4.42 Ha (Ac.11.00 Cts) land is required in

Sy.No.1 of Kumili Village of Poosapatirega Mandal to propose as alternative land for afforestation to Forest Department, Territorial Forest Division, Vizianagaram in compensation to the Forest lands utilized in TRTS Project for excavation of Tunnel, across Damarasing Reserve Forest hill range (Gurla Mandal). The proposed land is also accepted by the Forest Department.

The Tahsildar, Poosapatirega further submitted that A1 notice has been published in the Gram Panchayat Office, Kumili village on Dt.08.08.2015 and no objections have been received in the matter. the Gram Panchayat, Kumili has also passed resolution stating that they have no objection to transfer the land in Sy.No.1/1P of Kumili village in favour of the Executive Engineer, TRTS Project, Vizianagaram.

The Tahsildar, Poosapatirega further reported that, she has inspected the said land along with MRI, MS and VRO concerned on Dt.25.08.2015 and found that the land is vacant without any structures, buildings etc.. As per Revenue Records the land measuring an extent of Ac.11.00 cts in Sy.No.1/1 of Kumili village is classified as Sarkar Poramboke and no D-Pattas have been granted for the said land.

The Revenue Divisional Officer, Vizianagaram further reported that he has inspected the said land on Dt.09.09.2015 along with the Tahsildar, Poosapatirega, MRI, MS and VRO concerned and found that the land in Sy.No.1/1 is classified as Sarkar Poramboke measuring an extent of Ac.428.70 Cts. Out of which an extent of Ac.11.00 Cts (4.42 Ha) has been proposed for transfer, in favour of the Executive Engineer, TRTS Project, Vizianagaram for the purpose of alternative land for afforestation as tunnel across Damarasing Reserve Forest hill range (Gurla Mandal). The proposed land is vacant on ground, without any structures, buildings etc.. and no D-Pattas were granted earlier.

Finally the Revenue Divisional Officer, Vizianagaram recommended to transfer an extent of Ac.11.00 Cts (4.42 Ha) in Sy.No.1/1P of Kumili village, Poosapatirega Mandal in favour of the Executive Engineer, I & CAD Department, TRTS Project, Vizianagaram for the purpose of alternative land for afforestation as tunnel across Damarasing Reserve Forest hill range (Gurla Mandal).

In the reference 7th cited the Executive Engineer, TRTS Division, Vizianagaram has requested to handover the aforesaid compensatory Afforestation land measuring an extent of Ac.11.00 cts in Sy.No.1 of Kumili Village, Poosapatirega Mandal to the Forest Department.

As per Government Land Allotment Policy, vide Go.Ms.No.571, Dt.14.09.2012, Annexure - XII, for 10 to 25 acres of land transfers between State Government Departments, APLMA, Government of A.P., is the competent authority.


