13) Specific recommendation of DCF for acceptance or otherwise of proposal with reasons, for site specific proposal.

The proposal is recommended for acceptance; as the proposed forest lands is use for laying of underground OFC duct & cable within ROW of existing road Shamgaon to Vagheri, road passing through forest land in Shamgaon, Antwadi, Vagheri, Tal. — Karad, Dist. Satara. The road selected as the maximum area will be covered for mobile network and easy maintain for long period.

Executive Engineer, Public works Dept. Satara, has sanction permission for laying of underground OFC duct & cable within the ROW of existing road. Sh. 124 by order no DB/K-2/ 7434/ 2019. & P.A. has obtained the permission from Govt.of Maharashtra, Deportment of Information Technology by letter no MTS/ 065 /C No 63/ S-4,Dt.4/12/2019.

Proposal is recommended for C.A. may not be levied to this proposal, as proposal for laying of underground OFC, within RoW of existing road, Area not felling in N.P. & WL. Sanctuary, & there is no need of felling of trees. (fulfils the conditions laid by MoEF &CC guideline FC- 11/165/2019 Dt 27/07/2020) Authority has not started work in forest land and also in Non-Forest land. P. A. will start work after sanction by State Govt.

There is no alternative non-forest land available, and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. Hence this proposal is recommended for diversion of the forest land for laying of underground OFC Cable.
