Kishanganga Power Station applied for diversion of 0.9574 hectare of Forest land at downstream dam site for establishment of Security Unit for CISF at downstream dam site Gurez as per the then Laws of J&K Government (Copy enclosed). After the change of Forest Laws due to implementation of Gol Forest Act an online application bearing No: FP/JK/HYD/45204/2020 dated 01/09/2020 has also been submitted to Forest Department Government of J&K (Copy enclosed).

It is to mention here that there is no habitation in the proposed 0.9574 hectare forest area. As a per the requirement of Forest Act, it is requested that the inhabitant of the area falling under the proposed 0.9574 hectare forest area, if any, may be rehabilitated under recognition and vesting of Forest Right in accordance with the provisions for Schedule tribes and other traditional forest dwellers under FRA – 2008 (2 of 2007).


It is to mention here that the joint survey of the proposed area stands already completed alongwith the officials of the Forest Departments (Copy Enclosed).

Sir,

Kishanganga HE Project (330MW) has been commissioned in March 2018. The Dam of the project is located in Kanzalwan Gurez and the powerhouse is located in Kralpora, Bandipora.

As per the directions of Ministry of Home affairs, GoI, the CISF has been deployed in order to provide security to critical components of the project including Dam Site at Gurez. The CISF contingent is required to be housed in suitable residential units at Dam site in Gurez. With regard to availability of state/private land office of the Deputy Commissioner, Bandipora vide letter no DCB/LA/2019/6538 dated 25.10.2019 has certified that there is no state/private land available. A patch of forest land measuring 0.9574 ha has been identified considering safety and security of CISF personnel. Accordingly, in order to meet the requirement, a proposal for the diversion of 0.9574 ha of forest land on left bank of Kishanganga river downstream of dam site in Kanzalwan Gurez was submitted to the Department of Forest Government of J&K. We have received direction from Department of Forests, Government of J&K for resubmission of the said forest proposal online on Ministry of Environment Forest & Climate Change (MoEF&CC), GoI website (<https://parivesh.nic.in>)

In this regard, it is requested to direct the concerned officer to issue online NOC, with regard to non availability of state/private land, on MoEF&CC, GoI website (<https://parivesh.nic.in>).

## SITE INSPECTION REPORT

The site inspection of the proposed land was carried by the Undersigned on 02-09-2020 along with the representative of the User Agency and Range officer concerned (Gurez). The proposed site falls near Nyle village of Tehsil Gurez & as such no tree is involved in the proposed site. The area remains under heavy cover of Snow for a prolonged period ranging from 05 to 07 months. The site passes through Compartment 52/KG Kanzalwan Beat of Kanzalwan Block (Gurez Range). The composition of the crop in the proposed compartment is mostly Conifer with predominant specie of Fir. No any endangered species of flora & fauna are existing on the proposed site. No Archeological/Heritage site falls at the proposed site. The requirement of the forest land proposed by the User Agency is unavoidable & is having high importance from the point of view to accommodate the CISF personal downstream dam site areas of Gurez Valley. The diversion of forest land proposed is also inevitably required for the hassle free accommodation of CISF personal during the harsh winters.

Since the work has not been started as yet & there is no any question of any violation from the User agency & in no case will be allowed to take place while execution of the proposed work (Diversion of 0.9574 Ha for establishment unit for CISF downstream dam site Gurez).
