This permission is further subject to the following terms and conditions:-

- That the conditions of agreement executed by you with the Director, Town & Country Planning, Haryana, Chandigarh and the provisions of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act 1963 and Rules framed there under shall be complied with by you.
- That you shall pay the External/Internal Development Charges in case of extension of urbanizable limit in agriculture zone and HSVP any other developing agency provides the services in the area.
- 3. That you shall pay the additional amount of conversion charges for any variation in area at site in lump sum within 30 days as and when detected and demanded by the Director, Town & Country Planning, Haryana, Chandigarh.
- That you shall give at least 75% employment to the domiciles of Haryana where the posts are not of technical nature and a quarterly statement indicating the category wise total employment and of those who belongs to Haryana shall be furnished to the G.M.D.I.C, Yamunanagar.
- That you shall obtain occupation certificate from the Department after completing the building within two years of issuance of this permission.
- That shall obtain the standard design of building plans of petrol pump site, from Essar Oil and Gas. The standard design will be prepared keeping in view maximum permissible height of 8 meters (single storey) and minimum 3 meter set back. The standard design will be submitted in the office of District Town Planner, Yamuna Nagar for approval. The construction will be started within six months from issuance of permission.
- That you shall deposit labour cess before approval of building plans.
- You shall construct the service road, if any required to be constructed in concurrence with the PWD (B&R).

- That you shall have no objection to acquire the land, if required for road widening or for trunk services.
- 10. That this permission shall be valid for two years from the date of issue of this letter subject to fulfillment of the terms and conditions of the permission granted and agreement executed.

11. That this permission shall not provide any immunity from any other Act/Rules/ Regulations applicable to the land in question.
