Dear Sir,

With reference to the above, this is to bring to your notice that State Level Environment Impact Assessment Authority, Uttar Pradesh has granted conditional Environmental Clearance to UPEIDA for construction of Samajwadi Purvanchal Expressway vide your letter referred above. We have already submitted the six monthly report in November 2017. Now due to unavoidable circumstances of changing the alignment, the following amendments in the above granted Environmental Clearance are requested:-


1-Name of the project shall be modified to Purvanchal Expressway (Green Field) in place of Samajwadi Purvanchal Expressway. Copy of the Government approval letter dated 07.06.2017 is enclosed for your reference.

2- After careful study and to save the precious forest land, now in the final alignment the forest area involved is only 17.5714 ha. (9.1549 ha. as reserved forest and 8.4165 ha. as protected forest) in place of approx 35 ha. as informed at the time of grant of referred Environmental Clearance. It is requested to please amend the area of forest land involved as 17.5714 ha. in the place of approx. 35 ha. copy the government letter dated 03.01-2018 in enclosed for your reference.

Kindly do it at the earliest.
