**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF**

5.1 A proposal has been received by this office from **Executive Engineer** construction Division P.W.D.Nainital for diversion under FCA-1980) of 2.988 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Satoli Kaphura motor road** The site inspection of the land involved in the proposal has been done by me on dated **19-12-2018**

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring **2.988 ha.** Civil soyam Land/ van panchayat

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 6.00 किमी 0 लम्बाई तथा 9 मीटर चौड़ाई में प्रस्तावित किया गया था । जिसमें 223 वृक्ष विभिन्न प्रजाति के वृक्ष प्रभावित होते थे जिसमें बॉज प्रजाति के 57 वृक्ष प्रभावित होते । जिसमें वन पंचायत भूमि 345 मीटर यानि 0.3105 है 0 व सिविल एवं सोयम भूमि 2975 मीटर यानि 2.6705 हैं तथा नाप भूमि 6000 मीटर यानि 2.412 है 0 प्रभावित होती थी । उक्त प्रस्तावित मार्ग के समरेखण में वन पंचायत तथा सिविल एवं सोयम भूमि में 171 विभिन्न प्रजाति वृक्ष प्रभावित होते हैं जिसमें बॉज प्रजाति के 32 वृक्ष भी सम्मिलित हैं । ऑन लाईन 171 वृक्षों की पृविष्टी की गई हैं जिसमें बॉज प्रजाति के 32 वृक्ष भी सम्मिलित हैं । नाप भूमि में विभिन्न प्रजाति के 52 वृक्ष प्रभावित होते हैं । जिसमें बॉज के 25 वृक्ष हैं । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम समखोल, सतौली सोनापानी तोक सतौली ,कँफूडा , तथा चापड जिनकी परिवारों की संख्या 228 तथा जनसंख्या 1491 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु अग्रसारित किया जाता हैं ।
