### 13) Specific recommendation of DCF for acceptance or Other-wise of proposal with reasons.

The proposal is recommended for acceptance; as the proposed Forest lands is usefor laying of underground OFC duct & cable within ROW of existing road Mhaswad to Mardi, road passing through forest land in Palashi, Tal. - Man Dist. Satara. The road selected as the maximum area will be covered for mobile network and easy maintain for long period.

Proposal is recommended for C.A. may not be levied to this proposal, as proposal for laying of underground OFC, within ROW of existing road, Area not falling in N.P. & WL. Sanctuary, & there is no need of felling of trees. (fulfils the conditions laid by MoEF & CC guideline FC- 11/165/2019 dt 27/07/2020)

There is no other alternative non-forest land available, and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. Hence this proposal is recommended for diversion of the forest land for laying of underground OFC Cable.
