			Thus, the diversion area as per the field verification is 6.6766 Ha for "Erection of 33 KV Interlinking line from 33/11 KV SS Penchikalpet to Loadpally" with width of 15.00 Meters over a length of 4451.08 meters, which is falling in "Kadamba, Kadamba Ext-VI, Bejjur Ext – VII and Bejjur RF" in Kaghaznagar Division is recommended considering all the aspects mentioned in the proposal and field conditions. (A) The proposed diversion area is falling "Corridor of Kawal Tiger Reserve, which is noticed with Tiger Movement in this area and also wildlife movement as this
			area" .Therefore transmission lines in forest areas should be insulated (Aerial Bunched Cable) instead of overhead lines, due to protection of Wildlife. Hence it is recommended for considering the proposal; if above conditions (A) is agreed by the user agency.
