1. At the outset, Sh. K.C Meena, IFS, APCCF cum Nodal Officer (FC) welcomed all participants and briefed about provisions of Amended **Van (Sanrakshan Evam Samvardhan) Rules, 2023**, notified on 29th November 2023.

2. As per **Van (Sanrakshan Evam Samvardhan) Rules, 2023**, Project Screening Committee is to examine the completeness of the proposal submitted under clauses (i), (ii), (iii) of Sub Section (1) of Section 2 of the Adhiniyam, The project Screening Committee consists of the following Officers:-

1.	Nodal officer	Chairperson;
2.	Concerned Chief Conservator of Forests/Conservator of Forest	Member;
3.	Concerned Divisional Forest Officer	Member;
4.	Concerned District Collector or his representative (Not below the rank of Deputy Collector)	Member;
5.	Divisional Forest Officer in the Office of Nodal Officer	Member –Secretary;

“The project Screening Committee shall meet at least twice every month and the quorum of the meeting of the Project Screening Committee shall be three. The Project Screening Committee shall, after examination of the proposals, make recommendation to the State Government or Union Territory Administration, as the case may be ”.

3. As per **Van (Sanrakshan Evam Samvardhan) Rules, 2023** Para 9(4) " The Copy of the proposal shall be simultaneously forwarded to the concerned Divisional Forest Officers, District Collectors, Conservator of Forests, Chief Conservator of Forests and the Nodal officer of the State Government or Union territory Administration each of whom shall independently undertake preliminary examination of the completeness of documentation of the proposal. "The State Govt. has notified PSC vide order dated 04-10-2022 under FCA rules, 2022.

As per para 8 of Van (Sanrakshan Evam Samvardhan) Rules, 2023, the proposal returned to the user agency shall be resubmitted after addressing the deficiency, as identified under sub-rule (7) above, within a period of ninety day's failing which the proposal shall stand de-listed.

Agenda 5.3

Proposal No. – FP/HR/ROAD/155111/2020

Proposal Name:-Diversion of 9.7884 ha. of forest land for Work of Sohna Realignment of Rewari Sohna Palwal road NH 919 Old NH 71B from km 47.100to 49.350 in Sohna Hilly Portion on EPC mode in the State of Haryana.

Action taken Report in Previous PSC meeting:-

Proposal is not visible on Parivesh Portal as Parivesh 1.0 proposals have been migrated to User agency for resubmission and reprocessing in Parivesh 2.0 as per New FCA rules. Hence it was not discussed during meeting.

Observations/ Discussions during 29th PSC meeting :-

Proposal has been received in Nodal Office on 31.01.2024. User Agency has uploaded details of Non Forest land in Sehjawas and Mandawar villages and confirmed the consent of providing land for Compensatory Afforestation. DCF Gurugram has submitted Part-II with site specific CA scheme in Check list No. 18.

PSC examined the proposal during meeting and found that it is complete in all respects and recommended for forwarding it to Govt. of India through State Govt.

Agenda 5.15

Proposal No. – FP/HR/ROAD/409538/2022

Proposal Name – Diversion of 26.16 Ha. Forest land for improvement of NuhPalwal Road Km 2.00 to 32.00 SH 13 ID 3536 in Nuh and Palwal Districts of Haryana State

Action taken Report in Previous PSC meeting.:-

No representative of User agency was present during meeting to update about the reply to be submitted by User agency. Proposal is pending with user agency since 25-03-2023.

Observations/ Discussion during 29th PSC meeting :-

DGM Palwal attended the meeting and informed that they will provide complete details of forest land to be diverted with KML file to concerned DFO and joint inspection will be done as earliest, so that CA scheme may be prepared at the level of DCF Faridabad as decided by State Govt. in PWD (B&R) department proposals.

Nodal Officer (FC) requested User Agency to Co-ordinate with DFO Mewat and Palwal for needful action and submits the reply of EDS raised by MS, PSC accordingly.

PSC deferred the proposal to next meeting for consideration.

Agenda 16.3

Proposal No. – FP/HR/ROAD/426353/2023

Proposal Name – Widening and strengthening of Ch. Dadri to Bond road, MDR-124, in distt. Charkhi Dadri, Haryana. 13.2151 Ha.

Action taken Report in Previous PSC meeting.:-

User agency requested chairperson, PSC that it has been decided at State Government level that Non Forest Land will be provided to PWD (B&R) department from Land Bank created in Faridabad District.

Chairperson informed that user agency has to provide details of forest land to be diverted along with kml file to their concerned DFO and joint inspection may be carried out to ascertain number of trees to be felled and damage of plants for preparing CA scheme by DFO Faridabad. Joint Inspection Report will be sent to DFO Faridabad through concerned DFO for further necessary action. This inspection/ exercise will be carried out before next PSC, so that it may be considered and discussed in next PSC meeting for further processing of said proposal.

Observations/ Discussion during 29th PSC meeting :-

DFO Charkhi Dadri informed PSC that Joint Inspection will done shortly and request for preparing Compensatory Afforestation Scheme will be placed before DFO Faridabad soon.

Nodal Officer (FC) requested DFO Faridabad that preparation of CA scheme may be expedited at their level. As soon as request letter of concerned DFO along with Joint Inspection
