It is submitted that as per the above reference (1), of the Deputy General Manager (Tech) cum Project Director NHAI, it was informed to this office that the User Agency has applied online for the development of four laning Natham – Thuvankuruchi section of NH 785 E. The proposed road in the sketch is such that it passes through the Kilamarathukuttu reserved forest of Thuvankuruchi Range, Tiruchirappalli Forest Division. (Copy is enclosed herewith)


In the reference (2), assistance was requested to assess the tree enumeration to in the existing right of way of the project NH 785E (in private pattaland). As per the reference (3), Deputy General Manager (Tech) cum the Project Director has informed that the said project does not involve the forest land of Marungapuri section of Trichy Forest Division.

The said area was inspected by me on 23.01.2020 and 25.02.2020. The alignment done in the field for the proposed road does not involve the Reserved Forest of Thuvankuruchi Range, Tiruchirappalli Division.

Hence it is submitted that the proposal Natham – Thuvankuruchi road does not involve the Reserved forest land of Thuvankuruchi Range, Tiruchirappalli Forest Division.
